You first need to register with us by completing our **Registration Form**. Then if you wish to submit an "absentee bid" for any of the Lots advertised in our catalogue you may list these using the form opposite:

We will not accept any bids after Midnight on Tuesday 13th November. Please note that if we receive two identical bids we can only accept the one that pre-dates the latter. We do not accept telephone bids.

We will execute an absentee bid at the lowest possible price considering the reserve price. All Lots are subject to a "Reserve Price" below which the Lots will not be sold. The auctioneer may execute absentee bids during the sale clearly identifying these as "commission bids".

Cigars Unlimited charge a "Buyers Premium" of 15% of the hammer price. Value Added Tax at a rate of 20% will be added to the total amount of the premium or commissions.

Please Note. Payment of the "Buyers Premium" and Settlement of any successful bid for the Lots offered will be solely by means of Bank Transfer of funds to our Bank Account.

Cigars must be collected from our premises within 3 working days. If you require the cigars to be delivered – within the U.K only – we can arrange for delivery once payment has been received. An additional charge will be added to your final Invoice based on the delivery cost and Insurance required. We do not ship or send cigars abroad. Please allow 7 working days for delivery.

You are at liberty to inspect the cigars before placing a bid in order to satisfy yourself as to the condition of the cigars offered for sale. They will be available for inspection at our premises in Fulham during normal working hours until the 13th November. However sealed boxes will not be opened.

Please Note: This Sale will be conducted in accordance with Cigars Unlimited' s Terms & Conditions of Sale and that bidding and buying at the sale will be regulated by such conditions. IMPORTANT. You should read the terms and conditions relating to this sale which set out the charges payable by you on purchases that you may make as these are legally binding. They also limit Cigars Unlimited' s liability to bidders and buyers.
